Day 1: Srinagar Airport arrival and same day Local Sightseeing- Srinagar- Stay at Srinagar - 11th, Nov 2024

Both the gardens are built on a symmetrical plan of central waterways with fountains dividing a series of garden terraces. Visit Botanical Garden & Shankar Acharya temple. Check in to the Hotel. Thajiwas Glacier is the most prominent attraction of Sonmarg- the Golden Meadow in the picturesque valley of Kashmir. Dinner and night stay at the Hotel in Srinagar.
